Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Basis under which variance shall be considered {391-3-7.05 (2)(A-K)}: A

Description and Location of Proposed Activity:

Applicant proposes to impact 1,394 linear feet (34,968 ft2) of stream buffer along an unnamed impoundment that lies along a perennial tributary to Noses Creek to rehabilitate the existing dam and dredge the lake of sediment to increase volume capacity. The overall intent of the project is to construct a single-family residential subdivision. The project is located on Old Lost Mountain Rd. approx. 1-mi. from the intersection of Old Lost Mountain Rd. and Macland Rd.
