The proposed project will consist on constructing a <u>new mixed-use commercial and multi-family residential development on approximately 11.4 acres along Peachtree Blvd near Clairmont Road in Chamblee. This project will include a stormwater management system (i.e., underground stormwater detention vaults and hydrodynamic vortex separators). Construction activities will result in permanent impacts (299 linear feet, 14,950 square feet) to an unnamed tributary to Bubbling Creek (tributary to Nancy Creek) in the <u>Upper Chattahoochee Watershed.</u></u>
