Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a) and (k)(2)

Description and Location of Proposed Activity:

The proposed project will consist of constructing a *new* multi-storied building and parking deck and the associated infrastructure on ±15.65 acres along the Northeast Expressway / I-85 Frontage Road in Brookhaven. The proposed streambank stabilization will consist of removing invasive species, grading the steambanks to a more stable slope (including the floodplain cut area) and revegetating the buffer with multi-trophic, native riparian vegetation. This project will include an on-site stormwater management system (including dry extended and multi-purpose detention basins, *CrystalStream Technologies* (CST) separator and an underground stormwater detention system). This project will result in ±812 linear feet total (±12,914 square feet total) of buffer impacts along an unnamed perennial stream, a tributary to North Fork Peachtree Creek in the *Upper Chattahoochee Watershed*.
