Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Description and Location of Proposed Activity:

The proposed project will consist of constructing The Keep Campus (colocation data center) and associated infrastructure on approximately 97 acres along Switch Way/Douglas Hills Road between Six Flags Road and Thornton Road in Douglas County. This project will include an on-site stormwater management system (including dry detention basins and *CrystalStream Technologies* (CST) *CrystalClean* water quality vaults). Construction activities will result in ±4,196 linear feet total (±257,936 square feet total) of buffer disturbances along an unnamed perennial stream and two unnamed intermittent streams and ±30,920 square feet of buffer disturbances along an existing pond, tributaries to the Chattahoochee River in the *Middle Chattahoochee – Lard Harding Watershed*.
