Description and Location of Proposed Activity:

The applicant proposes to permanently impact a total of 1,682 linear feet (82,764 ft<sup>2</sup>) of stream and buffer along two unnamed tributaries to Camp Creek to construct two one-story warehouse distribution buildings totaling 242,840 ft<sup>2</sup> and 861,840 ft<sup>2</sup>, respectively. The project is located 0.8 mi. south on North Commerce Drive from the intersection of North Commerce Drive and Camp Creek Parkway.
