This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (b)

Description and Location of Proposed Activity:

Stormwater runoff has caused severe streambank erosion and failure along an unnamed intermittent stream in Wills Park near the intersection of Old Milton Parkway and Wills Road in Alpharetta. The proposed stream restoration project will consist of realigning the stream (i.e., installing rock and log j-hooks, rock cross vanes, constructed riffles and plunge pools,), replacing a rusting culvert with a bridge and stabilizing the streambanks (i.e., installing toe protection, vegetated soil lifts, streambank and bankfull bench matting and live staking). This project will result in ±1,260 linear feet total (±54,450 square feet total) of buffer disturbances along an unnamed intermittent stream, a tributary to Foe Killer Creek in the *Upper Chattahoochee Watershed*.
