Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (b)

Description and Location of Proposed Activity:

North Fork Camp Creek is currently piped under an *existing* recreational field located near the intersection of Dodson Drive and Jersey Road in East Point. The proposed stream restoration project will consist of *daylighting* approximately 1,015 linear feet of North Fork Camp Creek (i.e., removing the existing pipes, creating a natural stream channel with a bankfull bench, excavating the floodplain and stabilizing the streambanks (including mulching/matting, seeding, live stake cuttings (*Black Willow, Elderberry* and *Silky Dogwood*) and native riparian vegetation (*Red Maple, American Sycamore* and *Wax Myrtle*)). This project will result in 196 linear feet total (10,103 square feet total) of buffer disturbances along North Fork Camp Creek, upstream and downstream of the recreational field in East Point, in the *Middle Chattahoochee – Lake Harding Watershed*.

Summary of Rules Requirements for Variance Application:

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
