Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Basis under which variance shall be considered {391-3-7.05 (2)(A-K)}: D

Description and Location of Proposed Activity:

The applicant proposes to impact 2,158 linear feet (25,057 ft²) of stream buffer along Farrell Creek in 14 separate areas to upgrade and replace in-line the existing sewer line from 12" VCP with a 16" DIP. Upon completion of land-disturbing activities, the stream buffer will be restored to a naturally vegetated state to the extent practicable, or to current existing conditions. The project begins on Peachtree Corners Circle 0.2 mi. from the intersection of GA-141 and Peachtree Corners Circle.
