Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Basis under which variance shall be considered {391-3-7.05 (2)(a-k)}: a & h

Description and Location of Proposed Activity:

The applicant proposes to impact a total of 243 linear feet (5,529 ft²) of buffer to two perennial streams in the *Upper Oconee Watershed* and the *Upper Ocmulgee Watershed* for the Harbins Road interchange. Disturbance activities consist of clearing and grading, placement of fill, riprap, and installation of BMPs. The project extends approximately 2.03 miles along the intersection of State Route 316 and Harbins Road.
