This notice is issued to inform the public of a receipt of an Application for a variance submitted pursuant to a state environmental law. The public is invited to comment during the 30-day period on the proposed activity. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05(2)(a-k)}: (a, h)

Description and Location of Proposed Activity: **The proposed project would disturb the state-mandated 25 foot buffers for three resources to relocate the stream channel to accommodate a wider roadway footprint, placing of silt fence, and clearing of vegetation for construction access. Orange Barrier Fence will be placed beyond the silt fence to prevent additional impacts. The project would disturb the buffers of Intermittent Stream (IS) 02, IS10, and IS13. The Spout Springs road widening begins south of Thompsons Mill Road and continues to the Interstate-985 (I-985) northbound and southbound ramps.**

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
