This notice is issued to inform the public of a receipt of an Application for a variance submitted pursuant to a state environmental Law. The public is invited to comment during the 30-day period on the proposed activity. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(A-K)}: B

Description and Location of Proposed Activity:

Applicant proposes to impact 10,885 linear feet (544,250 ft²) of stream and buffer along four unnamed tributaries to Big Creek to perform stream restoration activities within the proposed U.S. Army Corps of Engineers Jackson Farms Compensatory Mitigation Site. The channels will be re-constructed using natural channel design and bioengineering techniques to improve the pattern, plan and profile of the channels as well as reduce sediment and erosion into the stream and increase biological habitat and promote water quality. The project is located on Big Creek Rd. off US-19N.

Summary of Rules Requirements for Variance Application:

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
