This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a) and (h)

Description and Location of Proposed Activity:

Stormwater runoff has caused severe streambank erosion and loss of property and has undermined an *existing* sanitary sewer lift station and manhole located along an unnamed intermittent stream near Morningside Drive in a residential neighborhood in Augusta. The proposed project will consist of grading the streambanks to a more stable slope, integrated bio-engineering practices (including vegetated rock gabions) and piping 294 linear feet of the stream with a 96" Ø concrete pipe with an energy-dissipating headwall and a gabion weir further downstream. Land-disturbing activities will result in buffer impacts (± 545 linear feet total, ± 22,651 square feet total) along an unnamed intermittent stream, a tributary to Lake Olmstead in the *Middle Savannah Watershed*.

Summary of Rules Requirements for Variance Application:

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
