The applicant proposes to impact 100 linear feet (2507 ft²) of stream buffer along the Little Satilla River to construct a vinyl bulkhead and a 6' x 40' wooden walkway for recreational access to the river. The bulkhead is necessary to control existing and ongoing erosion along the property. The project is located at 160 Royal Dr. in Glynn County.
