IMPORTANT CHANGES TO DRINKING WATER LABORATORY SERVICES AGREEMENTS

Since 1977, the Georgia Environmental Protection Division (EPD) has provided laboratory services to assist individual drinking water systems maintain compliance with the Georgia Safe Drinking Water Act of 1977 and the Georgia Rules for Safe Drinking Water. This comprehensive and cost effective laboratory testing program helps Georgia water system owners (owners) improve the quality of drinking water and protect public health.

To improve efficiency for both the EPD and owners, the EPD is streamlining the process for owners to obtain and maintain the EPD's drinking water laboratory services. For years, the EPD has sent contracts to owners, requiring them to be signed and returned, for a three year period of drinking water laboratory services. Beginning July 1, 2016, the EPD will be replacing the former contract with an automatically renewable Terms and Conditions agreement. Additionally, fee collection processes are being enhanced to allow electronic payment of fees through an electronic check transaction from the owner's checking or savings account. Finally, delinquent accounts will now be subject to a late penalty and may be sent to collections.

In April 2016, each owner will receive a copy of the new Terms and Conditions for Drinking Water Laboratory Services for review. The Terms and Conditions specify a 12 month period of service beginning on July 1st and ending on June 30th the following year. Owners have the option of changing or terminating their services prior to July 1, 2016 and prior to any subsequent renewal period that begins on July 1st. Should the owner choose to terminate services, the owner must provide written notice of termination at least thirty (30) days prior to the start of the 12 month testing period. Whether services are continued with the EPD or with another certified laboratory does not change the obligation of the owner to meet the requirements of the Georgia Safe Drinking Water Act of 1977 and the Georgia Rules for Safe Drinking Water.

WHAT IS NOT CHANGING:

- Costs for drinking water laboratory services are not changing this cycle; Any future changes to costs will be sent to the owner prior to the start of a new term
- Owner is still responsible for compliance with the Georgia Safe Drinking Water Act of 1977 and the Georgia Rules for Safe Drinking Water
- EPD continues to report laboratory results to the owner and submit data to the EPA
- Invoicing on an annual basis

WHAT IS CHANGING:

- Terms and Conditions agreement replaces former contracts, which expire on June 30, 2016
- Automatic renewal of the Terms and Conditions each year if public water system continues to submit laboratory samples for analysis and continues to pay the annual charge
- Electronic payments can be accepted online through the Georgia EPD Online System (GEOS)
- Overdue accounts will be subject to a late fee of 1.5% per month and may be subject to collections

WHAT WATER SYSTEM OWNERS NEED TO DO:

- Review the Terms and Conditions upon receipt
- Contact the appropriate EPD Compliance Office contact listed in the facility's permit in writing (letter or email) to:
 - Notify the EPD of a change in ownership
 - o Request a change in services being provided by the EPD lab
 - o Terminate the EPD's laboratory services
- Pay the annual fee when invoiced in July of each year
