# I. NOTICE OF APPLICATION FOR A NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT TO DISCHARGE TREATED WASTEWATER INTO WATERS OF THE STATE OF GEORGIA

NPDES permits are valid for a maximum of five years. Prior to expiration of an existing permit, a new application must be submitted and evaluated.

An antidegradation analysis is conducted, as applicable, for new or expanded point source discharges that are proposed. The analysis evaluates whether allowing lower water quality is necessary to accommodate important economic or social development in the area in which the waters are located. In all cases, existing instream water uses and the level of water quality necessary to protect the existing use is maintained and protected.

All municipalities must be in compliance with the Georgia Department of Community Affairs (DCA) Service Delivery Strategy in order to receive a permit.

Having reviewed such applications, the Environmental Protection Division (EPD) is considering the issuance of NPDES permits to the following applicants, subject to specific pollutant limitations and special conditions.

## NPDES PERMIT REISSUANCE

#### **CAMDEN COUNTY**

City of Kingsland, P.O. Box 250, Kingsland, Georgia 31548, NPDES Permit No. GA0037800, for the Water Pollution Control Plant located at 960 South Grover Boulevard, Kingsland, GA 31548. Up to 2.2 MGD of treated wastewater is being discharged to Saint Marys River in the Saint Marys River Basin. The draft permit also contains provisions for an expansion from 2.2 MGD to 4.4 MGD.

## **GREENE COUNTY**

Vulcan Construction Materials LLC – Siloam Quarry, 800 Mt. Vernon Hwy., NE, Suite 200, Atlanta, Georgia 30324, NPDES Permit No. GA0026743, for its crushed and broken granite quarry facility located at 1191 Bethany Church Road, Greensboro, Greene County, Georgia. Approximately 0.11 MGD of mine dewatering is discharged to an unnamed tributary of South Fork Ogeechee River in the Ogeechee River Basin.

#### **HART COUNTY**

BASF Colors & Effects USA, LLC, 29 Pinciaro Lane P.O. Box 390, Hartwell, Georgia 30643, NPDES Permit No. GA0031011, for its Mica mining facility located in Hartwell, Hart County, Georgia. Approximately 4.09 MGD of pit pumpout, process wastewater from the mica operations, and groundwater and stormwater runoff is discharged to Boyd's Creek (outfalls 001 and 005), Cedar Creek (outfalls 002, 003, and 004), and an unnamed tributary to Cedar Creek (outfall 006) in the Savannah River Basin.
