# I. NOTICE OF APPLICATION FOR A NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT TO DISCHARGE TREATED WASTEWATER INTO WATERS OF THE STATE OF GEORGIA

NPDES permits are valid for a maximum of five years. Prior to expiration of an existing permit, a new application must be submitted and evaluated.

An antidegradation analysis is conducted, as applicable, for new or expanded point source discharges that are proposed. The analysis evaluates whether allowing lower water quality is necessary to accommodate important economic or social development in the area in which the waters are located. In all cases, existing instream water uses and the level of water quality necessary to protect the existing use is maintained and protected.

All municipalities must be in compliance with the Georgia Department of Community Affairs (DCA) Service Delivery Strategy in order to receive a permit.

Having reviewed such applications, the Environmental Protection Division (EPD) is considering the issuance of NPDES permits to the following applicants, subject to specific pollutant limitations and special conditions.

#### NPDES PERMIT REISSUANCE

#### **CRISP**

Drexel Chemical Company, 1700 Channel Avenue, Memphis, TN 38113, NPDES Permit No. GA0047686, for its facility located at Highway 280 East, Cordele, Crisp County, Georgia. Approximately 6,000 gallons per day of treated wastewater from groundwater remediation is discharged to an unnamed tributary to Deep Creek in the Suwanee River Basin.

#### FRANKLIN COUNTY

City of Royston, 684 Franklin Springs Street, Royston, Georgia, 30662, NPDES Permit No. GA0021491, for its Water Pollution Control Plant (WPCP) located at 310 Springs Street Extension, Royston, Georgia 30662. 0.5 MGD of treated wastewater is being discharged to Hannah Creek in the Savannah River Basin.

#### RABUN COUNTY

Department of Natural Resources – Wildlife Resources Division, 3695 Highway 197 North, Clarkesville, Georgia 30523, NPDES Permit No. GA0029840, for the Lake Burton Fish Hatchery at 3695 Highway 197 North in Clarkesville, Georgia of Rabun County. The facility is adding outfall 001a, which discharges into Lake Burton in the Savannah River Basin.

#### TIFTON COUNTY

City of Tifton, Post Office Box 229, Tifton, Georgia 31793, NPDES Permit No. GA0048470 for its New River Water Pollution Control Plant (WPCP) located at 80 Old Brookfield Road, Tifton, Georgia 31794 (Tift County). Up to 8.0 MGD of treated wastewater is discharged into the New River in the Suwannee River Basin.
