Description and Location of Proposed Activity:

The proposed project will consist of the installation of an 8 in diameter gravity sewer line along US 441 in Rabun County. Stream buffers will be stabilized after construction. This project will result in approximately 320 linear feet total (11,112 square feet total) of buffer impact along an unnamed tributary of the Little Tennessee River in the Little Tennessee River Watershed.
