Type of Permit Application: Variance to encroach within the 50-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05(2)(a-k)}: (a)

Description and Location of Proposed Activity: **The proposed project would impact Perennial Stream (PS) 09a and PS10 for the widening and re-alignment of County Road (CR) 68/Hulsey Road from a two-lane rural roadway to five lanes with a center, two-way, left turn lane and 10-foot wide rural shoulders. The project would impact the 50-foot state mandated buffer of unnamed tributaries to Tesnatee Creek within the Upper Chattahoochee watershed. The proposed project begins at the intersection of CR68/Hulsey Road and U.S. Highway (US) 129/State Route (SR) 11 and continues east along the current alignment of CR 68/Hulsey Road, ending at the intersection of CR 68/Hulsey Road and SR 75.**
