#### **Environmental Covenant**

This instrument is an Environmental Covenant executed pursuant to the Georgia Uniform Environmental Covenants Act, O.C.G.A. § 44-16-1, et seq., as may be amended from time to time (hereinafter the "Act"). This Environmental Covenant is entered into by the entities executing this Environmental Covenant and subjects the Property identified below to the activity and/or use limitations and other requirements specified in this document. This Environmental Covenant further grants such other rights in favor of the Georgia Department of Natural Resources Environmental Protection Division ("EPD"); the United States Environmental Protection Agency ("EPA"), a Third-Party Beneficiary; and Honeywell International Inc.; as set forth herein.

#### **Subject Property**

The property subject to this Environmental Covenant is a tract of approximately 87.2-acres of real property located at 4125 Ross Rd. in Brunswick, Glynn County, Georgia, consisting of uplands owned by Honeywell International Inc. (hereinafter "Property"). The parcels that make up the Property consist of three tracts of various sizes, including tracts of 59.8 acres, 5.7 acres, and 21.7 acres, which are further identified by the tax parcel ID numbers below. The parcels include real property conveyed by that certain limited warranty deed dated November 23, 2015, from Georgia Power Company to Honeywell International Inc., recorded in Deed Book 3520, Page 371, of the Glynn County, Georgia deed records, as well as portions of the real property conveyed by that certain conveyance dated May 15, 1998, from Hanlin Group, Inc., formerly known as LCP Chemicals & Plastics, Inc. to AlliedSignal Inc., recorded in Deed Book 433, Page 287, of the aforesaid deed records (Honeywell International, Inc. being successor by merger to the said AlliedSignal Inc. as evidenced by Certificate of Ownership and Merger recorded in Deed Book 3009, Page 444, of the aforesaid deed records).

A complete legal description of the Property is attached as Exhibit A, and a map of the Property is attached as Exhibit B. Exhibit B is intended only to provide a visual depiction of the Property areas and is not legally binding; in the event of a conflict between Exhibit A and Exhibit B, the legal descriptions in Exhibit A control.

The tax parcels of the Property are 03-04612 and 03-08939 of Glynn County, Georgia.

The Property is part of the LCP Chemicals (Georgia) Superfund Site, which was placed on EPA's National Priorities List on June 17, 1996.

#### **Environmental Covenant Runs with the Land and is Perpetual**

Pursuant to the Act, this Environmental Covenant shall run with the land and shall be perpetual unless terminated or amended pursuant to terms herein or in accordance with provisions of the Act. This Environmental Covenant shall be binding upon Honeywell International Inc. (hereinafter "Honeywell") and all successors, assigns and transferees of any interest in the Property or any portion thereof.

#### **Administrative Records**

This Environmental Covenant imposes activity and/or use limitations and other requirements on the Property that arise under removal and remedial actions performed and/or being performed at the Property pursuant to the Comprehensive Environmental Response, Compensation and Liability Act, 42 U.S.C § 9601 et seq. #### **Activity and Use Limitations**

The is subject to the following activity and/or use limitations:

- 1. Non-Residential Use. The Property shall be used in accordance with the allowed uses only for non-residential property, as defined in Section 391-3-19-.02 of the Rules and Regulations of the State of Georgia ("Rules") as of the date of this Environmental Covenant. The Property is not to be used as residential property as defined in the Rules, and any residential use on the Property shall be prohibited. Further, any activity on the Property that may result in the release or exposure to the hazardous substances that were addressed as part of the response actions, or create a new exposure pathway, is prohibited.
- 2. <u>Groundwater</u>. The use or extraction of groundwater beneath the Property for any non-remedial purposes shall be prohibited unless conducted under a plan prepared in accordance with generally accepted engineering principles and submitted in writing to and approved by EPD and EPA.
- 3. <u>Interference with Remedy</u>. Use of the Property shall not damage or interfere with any part of the monitoring or remediation systems on the Property, including any

- capping, soil covers, wells, piping, and other equipment, either above or below the ground surface.
- 4. <u>Soil Disturbance</u>. Any work on the Property where surface or sub-surface soils are to be disturbed, including excavation, construction, utility installation or maintenance ("Soil Disturbance"), shall be performed by informed and properly trained personnel using appropriate personal protection equipment in accordance with rules established by the federal Occupational Safety and Health Administration applicable to the risks present at the Property. Any soil generated from such Soil Disturbance for off-site disposal shall be properly characterized and managed in accordance with applicable local, state and federal rules and regulations governing the disposal of such material.
- 5. <u>Vapor Intrusion</u>. The owner of the Property shall not allow any new building construction on the Property unless the owner of the Property conducts a vapor intrusion assessment and employs appropriate mitigation measures, if indicated as necessary by the vapor intrusion assessment.
- 6. <u>Signage</u>. A permanent marker shall be installed and maintained at the Property that identifies a Type 5 restriction as specified in Section 391-3-19-.08(7)(b)(4) of the Rules. Disturbance or removal of such marker is prohibited.

#### **Other Requirements**

- 1. <u>Notice of Limitations and Requirements in Future Conveyances</u>. Each instrument hereafter conveying any interest in the Property or any portion thereof that may affect the activity and use limitations described herein shall include a statement that the Property is subject to this Environmental Covenant (and any amendments thereto), the location (County, Deed Book and Page) in the deed records where this Environmental Covenant (and any amendments thereto) is recorded and a copy of this Environmental Covenant (and any amendments thereto).
- 2. Notice to EPA and EPD of Future Conveyances. Within thirty (30) days after each conveyance of a fee simple interest in the Property or any portion thereof, a notice shall be sent to EPA and EPD. The notice shall include the new owner's name, address, telephone number and other pertinent contact information, the date of the conveyance and the location (County, Deed Book and Page) where the conveyance is recorded, and, if the conveyance is a portion of the Property, a survey map showing the boundaries of the real property conveyed.
- 3. <u>Notice of Change of Use</u>. If such activity will materially affect any required monitoring or maintenance of any institutional or engineering controls described herein, the owner of the Property must provide to EPA and EPD thirty (30) days' advance written notice of the owner's intent to change the use of the Property, to apply for a building permit for construction at the Property, or to perform any site work.

#### **Environmental Covenant Does Not Authorize Use Otherwise Prohibited**

Pursuant to the Act, this Environmental Covenant shall not be construed to authorize a use of the Property that is otherwise prohibited by zoning, ordinance, local law or general law or by a recorded instrument that has priority over this Environmental Covenant.

#### Rights of Access and Enforcement

Authorized representatives of EPA and EPD shall have the right to enter the Property at reasonable times in connection with implementation, compliance, or enforcement of this Environmental Covenant, including but not limited to the right to conduct inspections, examine related records, or to take samples.

This Environmental Covenant shall be enforceable by EPA, EPD, and other parties as provided in the Act. EPA is a Third-Party Beneficiary of this Environmental Covenant, and, as such, has the authority to enforce the Environmental Covenant to the extent such enforcement is allowed by law.

Such rights of access and enforcement herein shall not limit EPA and EPD's authority under other applicable law.

#### No Interest in Real Property in EPA and EPD

EPA's and EPD's rights under this Environmental Covenant and the Act shall not be considered an interest in real property.

#### Recording of Environmental Covenant and Service on Other Persons

Following the execution of this Environmental Covenant by EPA and EPD, Honeywell International Inc. shall record the Environmental Covenant in every county in which any portion of the Property is located in accordance with the law governing the recording and priority of interests in real property. Upon recording of the Environmental Covenant, Honeywell International Inc. shall provide in a manner deemed acceptable by EPA and EPD a copy of the executed, recorded Environmental Covenant to each of the persons or entities identified in O.C.G.A. § 44-16-7.

#### Representations and Warranties by Grantor

Honeywell International Inc. represents and warrants that all of the following are true and correct:

- 1. Honeywell International Inc. holds fee simple title to the Property.
- 2. Honeywell International Inc. has the authority to enter into this Environmental Covenant, has the authority to grant any rights granted by it within, has the ability to carry out the obligations described within and, based upon information and belief after reasonable inquiry, does not know of any anticipated material change

- in the practices, ownership, or authority of Honeywell International Inc. that will alter this representation and warranty.
- 3. The execution and delivery of this Environmental Covenant and carrying out the obligations described within will not conflict with any of the provisions of the organizational documents, operating agreement of Honeywell International Inc. nor will it violate, contravene and/or constitute a breach or default under any agreement, contract, order or instrument to which Honeywell International Inc. is a party or by which Honeywell International Inc. may be bound.
- 4. Honeywell International Inc. has identified all persons with existing interests other than fee simple in the Property and has determined the type and status of their interests; for those interests where the type and/or status make it necessary, the person's agreement to and signature on this Environmental Covenant or subordination of the interest has been obtained; and the aforementioned information regarding all interests other than fee simple in the Property has been provided to EPA and EPD.
- 5. This Environmental Covenant does not authorize a use of the Property that is otherwise prohibited by zoning, ordinance, local law or general law or by a recorded instrument that has priority over this Environmental Covenant.
- 6. At least thirty (30) days prior to executing this Environmental Covenant, Honeywell International Inc. served a copy of the proposed final text of this Environmental Covenant on all persons or entities required to be noticed in accordance with O.C.G.A. § 44-16-7.
