In addition to informing the public about the draft 2024 305(b)/303(d) List package, this notice also serves to inform the public about the development of Georgia's new 303(d) Prioritization Framework. In 2022, US EPA released a document entitled "2022 - 2032 Vision for the Clean Water Act Section 303(d) Program" (2022-2032 303(d) Vision) to help coordinate and focus efforts to advance the effectiveness of CWA Section 303(d) program implementation. Under the 2022-2032 303(d) Vision Document, states will develop a new Priority Framework that will guide the decision process on what TMDLs, Advance Restoration Plans or Protection Plans will be prioritized for completion by 2032. Every two years, EPD will provide US EPA with a list of Priority waters for which we plan to develop TMDLs or other plans in the next two-year period. The first set of Priority Waters under the 2022-2032 303(d) Vision will be provided to US EPA by September 30, 2024 (for plan development by 2026). The draft revision of EPD's 303(d) Prioritization Framework will be available on EPD's Water Quality in Georgia webpage in the near future. A separate notice will be sent when the draft document is available and open for public comment.
