

PUBLIC NOTICE
Notice of Intent to Renew Permit

The Environmental Protection Division (EPD) of the Georgia Department of Natural Resources, in accordance with the Georgia Hazardous Waste Management Act, O.C.G.A. 12-8-60 *et seq.*, as amended, announces its intent to renew Hazardous Waste Facility Permit No. HW-092(D) issued to Matthews International Corporation (d.b.a The York Group/York Casket Hardware), Lawrenceville, Georgia (York) for post-closure care and corrective action for two closed hazardous waste management units. The closed units are located at 506 Maltbie Street, Lawrenceville, GA 30046, identified by EPA ID number GAD003265030.

This permit addresses post closure care for the closed hazardous waste management units, corrective action for groundwater contamination, and corrective action for solid waste management units. **NO ADDITIONAL DISPOSAL OF HAZARDOUS WASTES AT THE FACILITY WILL BE ALLOWED UNDER THIS PERMIT RENEWAL.**

The State of Georgia received final authorization for the 1984 Hazardous and Solid Waste Amendments (HSWA) to the federal Resource Conservation and Recovery Act (RCRA), as amended, on September 18, 1986. Therefore, upon issuance, the permit will constitute a full RCRA permit as required by the Georgia Hazardous Waste Management Act and RCRA.

The draft permit has been prepared in accordance with the Georgia Rules for Hazardous Waste Management, Chapter 391-3-11. Before finalizing its decision to renew the permit, Section 391-3-11-.01 (which incorporates 40 CFR 124.10 by reference) of the Rules requires EPD to provide an opportunity for public comment. Accordingly a public comment period has been established from June 23, 2016 to August 9, 2016. During the public comment period, a copy of the draft permit and permit renewal application will be available for review at the following locations during regular business hours:
