

PUBLIC NOTICE
Notice of Intent to Amend Permit

The Environmental Protection Division (EPD) of the Georgia Department of Natural Resources, in accordance with the Georgia Hazardous Waste Management Act, O.C.G.A. 12-8-60 et seq., as amended, announces its intent to amend hazardous waste facility permit number HW-103(D), issued to A.I.D. Company, division of Roller Bearing Company of America, Inc., to include a soil and groundwater corrective action plan and terminate the permit when the corrective action plan has been implemented and a consent order executed. This facility is owned by A.I.D. Company, division of Roller Bearing Company of America, Inc., and is located at 250 Laurel Heights Drive, Clayton, GA 30525, identified by EPA ID number GAD 003292885. THIS PERMIT MODIFICATION DOES NOT AUTHORIZE ANY ADDITIONAL DISPOSAL OF HAZARDOUS WASTE AT THE FACILITY.

The current permit requires A.I.D. Company to conduct post-closure care at the Facility. The draft permit amendment and consent order, which are the subject of this notice, proposes a soil and groundwater corrective action plan, permit termination when the corrective action plan has been implemented and a consent order executed to monitor the effectiveness of the corrective action. This is to ensure that A.I.D. Company continues to comply with the currently applicable requirements in 40 CFR Parts 124, 260 through 266 and 270.

The State of Georgia received final authorization for the 1984 Hazardous and Solid Waste Amendments (HSWA) to the federal Resource Conservation and Recovery Act (RCRA), as amended, on September 18, 1986. Therefore, the permit, as amended, will constitute a full RCRA permit as required by the Georgia Hazardous Waste Management Act and RCRA.

The draft permit amendment has been prepared in accordance with the Georgia Rules for Hazardous Waste Management, Chapter 391-3-11. Before making its final decision to amend the permit and execute the consent order, Section 391-3-11-.11(4)(b) and Section 391-1-3-.01 of the Rules requires EPD to provide an opportunity for public comment. Accordingly, a public comment period has been arranged from June 7, 2018, to July 24, 2018. During the public comment period, a copy of the draft permit and corrective action plan will be available at the following locations during regular business hours:
