

PUBLIC NOTICE  
Notice of Intent to Modify Permit

The Environmental Protection Division (EPD) of the Georgia Department of Natural Resources, in accordance with the Georgia Hazardous Waste Management Act, O.C.G.A. 12-8-60 et seq., as amended, announces its intent to modify the hazardous waste facility permit issued to Union Carbide Corporation (Union Carbide) for post-closure care and corrective action of a closed hazardous waste landfill. This landfill is located on Harriet's Bluff Road in Woodbine, Camden County, GA, 31569, and is identified by EPA ID number GAD981235294.

The draft permit requires Union Carbide to perform corrective action and conduct post-closure care at the facility. The permit modification, which is the subject of this notice, modifies the existing permit for the purpose of a regulatory completeness review pursuant to 40 CFR 270.50(d), as well as modifying Section 12 of the permit application, titled Todd Creek Bank Stabilization Plan. **NO ADDITIONAL DISPOSAL OF HAZARDOUS WASTES AT THE FACILITY WILL BE ALLOWED UNDER THIS PERMIT MODIFICATION.**

The State of Georgia received final authorization for the 1984 Hazardous and Solid Waste Amendments (HSWA) to the federal Resource Conservation and Recovery Act (RCRA), as amended, on September 18, 1986. Therefore, upon modification, the permit will constitute a full RCRA permit as required by the Georgia Hazardous Waste Management Act and RCRA/HSWA.

The draft permit has been prepared in accordance with the Georgia Rules for Hazardous Waste Management, Chapter 391-3-11. Before finalizing its decision to modify the permit, Section 391-3-11-.01 (which incorporates 40 CFR 124.10 by reference) of the Rules requires EPD to provide an opportunity for public comment. Accordingly, a public comment period has been established from February 9 to March 28, 2017. During the public comment period, a copy of the draft permit will be available for review at the following location during regular business hours:
