Description and Location of Proposed Activity:

The applicant proposes to widen and improve Little Road in Cherokee County. The project proposes to impact a total of 4,037 square feet (365 linear feet) of stream buffer to two (2) perennial streams tributaries to the Etowah River Basin. Disturbance activities include clearing, fill, channel relocation, installation of orange barrier fence and type C silt fence.
